<u>Renewal of Licence U/S 13 of the Punjab Agricultural</u> <u>Produce Markets Act, 1961.</u>

Overview:-

To continue the license for Palledar, renewal is required for further period of 3 years, if the applicant is desirous to continue.

Who can apply:-

A license granted under section 13 of the Act shall be valid for the period for which it is issued and shall, subject to any order passed under section 10 (2) of the Act or rule 19 (5) be renewable by the authority granting it, on payment of the annual fee prescribed for the issue of such license. Renewal application shall be made in Form G for licenses under section 13.

Fee Schedule:-

- Renewal Fee Rs. 20/- (for 3 years).
- Penalty Fee Rs. 20/- (in case of renewal applied within grace period i.e in April)

Documents required for Renewal of License U/S 13 of the Punjab Agricultural Produce Markets Act, 1961.

- **1.** Identity Proof of applicant (Certified Copy).
- 2. Undertaking from the licensee firm from where the License was issued for renewal of license U/s-13.
- **3.** Copy of License (Form E)
- 4. Form G
